- Car Rental Permit issued by the Ministry of TEATT;
- Chamber of Commerce Registration;
- Proof of payment for the 2025 Business and Director's license (where applicable);
- A Microsoft Excel spreadsheet listing all vehicles within the fleet;
- Copies of all 2026 Road Tax receipts.
